The Vice-President read a letter of application for membership from Donald B. Davis W9LTY. The motion was made and seconded to accept him as an active member. The motion was accepted unanimously. The Secretary was instructed to write Mr. Lewis informing him of the Association's acceptance.

A discussion was held concerning the setting of a time limit for the payment of dues and initiation fees for those persons eligible to become charter members. the motion was made and seconded that eligibility for charter membership be limited to 1 June 1951. The motion was accepted unanimously.

The Vice President reported that Don Davis, W9LTY, had volunteered to conduct on the air code practice on 10 meters. He was, therefore, delegated as official code practice chairman.

In the light of Don Davis' physical handicap, a motion was made and seconded to waive his dues and initiation fees for the remainder of the calendar year of 1951. The motion was accepted unanimously.

Minutes of Meeting 23 April 1951
