#### TARA BUSINESS MEETING

Tuesday, May 13, 1997

#### **CALL TO ORDER**

The meeting was called to order at 1930 hours by club president Bob Martin (W9YE). Those in attendance are as follows:

1. Howie Koehl (KZ9Z), read the minutes from the March and April meetings which were approved with the following corrections.....

a. The Ham Radio demonstration for Veteran's Week is on June 10th not June 24th.

- b. Field Day Auction is being held on May 28th not May 25th.
- 2. Jim Canarecci, WA9TGO, gave the treasurer's report which was accepted as read and contained items such as....

a. Collection of dues

b. Payment of the trailer license plate

c. Intérest on CD

d. Checking and Savings account balances with total club assets @ \$13,553.42

#### **OLD BUSINESS**

- 1. Bob Martin met with the Red Cross Executive Director and was given a memo covering requirements for climbing the tower for antenna work. The memo stated that requirements have been modified to read that routine maintenance is approved but for any major changes, we must submit a written request for their approval. The memo also stated some club members would be assigned keys to the building. For more in-depth information, see Bob. He will sign the letter, get her signature, and pass it to the club secretary.

- 2) Hams will have to use the street or the library lot since we won't be able to park in the Red Cross parking lot.
- 3) You may pull into the lot, unload your equipment, and then move your vehicle out of the lot.

4. Steve Stombaugh (N9DHH) reported on the bus to Dayton Hamvention. He will need \$100 from the club treasury (voted on at last meeting) to meet final cost on the van from Lafayette Limo. It was moved and seconded to write the check.

### Additional radio spectrum discovered Dick Sisson, W50NL

Investigators recently uncovered some lost documents from a classified research project conducted during World War II. The project has now been declassified, making this report possible. This research discovered a hitherto unknown region of electromagnetic spectrum below zero cycles per second. Although referred to in the documents as "Negacycles," this region will no doubt now be known as a "Negahertz.

Several interesting phenomena were reported concerning the properties of this region and the equipment used in the tests. The conclusion of the limited research showed, antennas of negative length, termed "imaginary antennas," performed remarkably well at these frequencies, particularly when buried "the deeper the better."

Wartime security prevented extensive evaluation of propagation in this new portion of the spectrum, but the documents indicate researchers were optimistic about its potential for meeting special communications needs. Preliminary findings did indicate the best propagation seemed to

coincide with sunspot minimums.

Space limitations here do not permit inclusion of the many pages of complex mathematical calculations supporting the various conclusions in Suffice it to say that the "j" numbers in the the research notes. calculations take on a whole new meaning when applied to these frequencies.

One of the more critical problems the researchers encountered was the severe chilling of the components when running at high power on these frequencies. A number of defrosting methods were tried, but only with limited success.

The entire project was finally discontinued in mid-summer 1943, when tests conducted in the Mojave Desert ended in the loss of several members of the research team to hypothermia, exposure, and frostbite. Since all of the research was conducted entirely with vacuum tube equipment, it remains for modern day researchers to explore the impact of newer solid state technology on this problem.

### W9REG Antenna Proposal

#### **Current Situation**

The antenna committee has started the job of removing, repairing or replacing, then reinstalling all antennas and feed line on the tower. The work began late last fall. To date, the 2M and 440 Verticals have been removed. Further work has been delayed, pending good weather.

- The job of removing all the existing antennas, performing repairs and/or acquiring replacements, reinstalling all antennas and repairing and/or replacing all coax is a very big job.
- Antenna removal/installation is dangerous work and volunteers are scarce.
- There have been a number of discussions about the type of feed line that should be used. No consensus has been reached.
- The existing 2M beams are horizontally polarized. One (at least) needs to be vertical.
- The 2M and 440 vertical antennas are the ones most likely to be needed in a local emergency situation. The six meter antenna is unusable.
- W9REG is effectively off the air for local emergency communications.

#### Proposal:

- I. The antenna committee should seek bids from companies to:
  - a) Replace the coax feed line with all new cable.
  - b) Remove the existing antennas and rotor.
  - c) Install an entirely new antenna farm and rotor system.
  - d) Inspect and if necessary, paint and/or repair the tower.
- II. Present finished bids at the next business meeting, at which time the club will vote to select one bid and authorize the expenditures.

By using a crane, the tower work can be completed in one or two days. The cable work will require several more days. In this manner, the entire job can be completed in about a week.

The antenna farm should include an HF beam and both omni-directional and beam antennas for 2M, 6M and 440Mhz.

By installing only heavy duty antennas and rotor and using only stainless steel hardware (brackets, bolts, etc.), this should be the last major tower work for at least a decade.

#### FROM YOUR PRESIDENT:

During the meeting this week on Tuesday, May 13, several things were decided that I think the whole membership needs to know.

- 1. I have had a meeting with the Red Cross Executive Director concerning our tower work and any liability incurred. She indicated that the RC has only \$10,000 liability for bodily injury and medical expenses therefrom. The club voted to change our insurance coverage to a general policy with a cap of \$1 million for liability and to also cover any outside activity that we may engage in such as Field Day, Hamvention, etc. Bruce Stewart will negotiate such coverage and we have given the Treasurer authority to pay such a bill, which will amount to somewhere around \$200.00 or slightly more. This is only a little more than we are now paying for much less coverage.
- 2. She has asked us to use the inside stairway to use the bathroom or to get a drink, etc., instead of going to the outside door. They will no longer come to the outside door outside of regular office hours as they have had trouble with homeless, strays, etc., interupting their meetings and making them generally uncomfortable, etc.
- 3. The downstairs meeting room will be remodeled soon and we may not be able to use it if it is done during one of our regularly scheduled business meetings. She will keep us posted on the dates involved.
- 4. Our next meeting on May 28 is our program meeting date and that day we will have our FD auction. The Red Cross will have a big meeting upstairs that night and will be using all of the parking spots for their attendees. PLEASE DO NOT park on their lot that night. The auction will be held as usual in front of the garage door and perhaps slightly inside the garage entrance We felt it was too late to inform the membership and try to have the auction at a members house, etc.
- 5 Curtis Sherwin is going to give us a report next month on the antennas and will order and get the necessary materials to get the antennas in order ASAP as we are essentially off the air with our equipment at the Ham Shack at the RC until we get this done. This is to be done on a priority basis to get us back in business.
- 6. Jeff Stewart needs help with the Purdue 4-H/FFA meeting on June 7. Get in touch with him to volunteer if you can do so.
