### TARA BUSINESS MEETING

Tuesday, August 12, 1997

### **CALL TO ORDER**

The meeting was called to order at 1930 hours by club president Bob Martin (W9YE). Those in attendance are as follows:

- 1. Howie Koehl, KZ9Z, read the minutes from the last meeting which were approved as read.
- 2. The TARA Field Day report was given to Bob Martin who informed the group the report would be mailed to the ARRL and should be in the December issue.
- 3. Jim Canarecci, (WA9TGO), gave the treasurer's report......amounts reported here are approximate (~).
  - a. No dues received
  - b. \$1106.00 disbursements
  - c. \$ 172.00 checking account balance
  - d. \$5840.00 savings account balance
  - e. \$6130.00 CD
  - f. \$12,147.00 Total Assets

### **OLD BUSINESS**

- 1. Antennas and Tower work.....Curtis Sherwin (WD9SWD) reported:
  - a. All antennas (except 6m beam) and rotor are down from the tower.
  - b. A hole needs to be cut into the rotor base plate to allow the mast pole to be lowered to facilitate removal/installation of antennas.
  - c. Mike Diener (KB9JDA) was very helpful on the tower work. Also had good ground support people.
  - d. Plans for the new installation will be proposed next month. A Force 12 antenna will be the HF beam.
  - e. The new installation needs to be completed before cold weather.
  - f. The following is a rundown of approximate costs for the new installation:
    - 1) Force 12 antenna (~ \$1200)
    - 2) Rotor (will check for wear but if new one needed ~ \$400)
    - 3) Coax (need 3 runs of coax and recommending a remote relay ~ \$200)
    - 4) Heliax is OK.
    - 5) 6M beam (do we put one up or not-yes at ~ \$200)
    - 6) 2M beam (~ \$300)
  - g. Ed Delp (N9YTE) motioned to authorize Curtis to spend up to \$3500 for all needed antennas and associated items. Tim Gardner (KB9JDE) seconded. A vote was taken and the motion carried.
  - h. Bob Martin requested the club secretary write a memo to the Red Cross inform them of our intentions on replacement of the antennas. A copy of this memo is included.
- 2. Bob Martin informed the members that we not operate the club station while the church located next door was in session because of interference to their public address system. The church contacted the Red Cross who in turn contacted Bob. A discussion followed...
  - a. Bob Finch (W9YA) wants the church to deal with us not the Red Cross.
  - b Ed Delp suggests a member contact the church regarding correction of their problem.
  - c. Curtis Sherwin said we need to be good neighbors and help them. We need to inform them about Ham Radio and offer to help with suggestions on correcting the problem.
  - d. Jim Davis (WA9LYC) offered the club the use of his FCC Interference Rule Book to assist if needed.
  - e. Bob Martin will talk to the Red Cross and the church regarding the problem.
  - f. Bob Finch volunteered to attempt to identify the problem(s).

3. Insurance....(There are still some concerns and comments on insurance coverage.)

a. We have liability coverage but not sure the extent of coverage.

b. No members are insured.

c. Jim Canarecci stated the need for an explanation of coverage in writing such as a copy of the policy.

d. Bruce Stewart (N9GKE) said we should be able to get someone from Henriott Insurance to appear before the club to explain the coverage.

# Field Day 1997 Report (continued) Submitted by: KF9UP

Beautiful weather made for a great Field Day weekend as we returned to the Indiana Veteran's Home site. The TEMA and TARA trailers were delivered on Friday, and located to provide shelter for our two primary stations.

Most of Friday afternoon and evening were spent shooting lines into trees to raise the various wire antennae which were to be used the following day. Curtis Sherwin, WB9SWD, wielded his might bow with some improved arrow designs and Steve Van Frank, WB9NIF, nimbly placed lines in the trees with his slingshot.

Saturday saw continued antenna work as radio equipment arrived and was installed. After Jack Kueberth, KB9KUQ, had the generator up and running, computers, loaned to us by Bob Martin, W9YE, Curtis, WB9SWD, Bruce Stewart, N9GKE, and Jeff Stewart, KF9UP, were readied by Bob Finch, W9YA and assigned to station locations. This year, "WR9R" Field Day logging software was used.

The Club's Corsair was used for CW this year and was located in the TEMA trailer. The TARA trailer housed the phone station for which W9YE, furnished his Yaesu FT-890. Bob also provided his new Icom 821H for use by the satellite group. Mark McGregor, KB9KHM, Mark Stover, KB9KLM, Steve Belter, WB9SGP, and possibly others, provided various antennas, computers, tables, etc. for satellite operations. Equipment for the Novice station was provided by KF9UP in the form of a Ten-Tec Triton IV.

KB9KUQ, made arrangements to use the TEMA generator trailer to provide power. The generator worked fine until it was powered down for refueling. Unfortunately, after it had been fueled, it would no longer generate any power. After some fiddling (no, we didn't go to Battleground), a backup generator was put in service and we were back on the air.

Meals were provided by Dan Steill, KE90V. Nourishment – sandwiches and chips for lunch, steak, salad, and chili for dinner, and bacon and eggs for breakfast – was expertly prepared and speedily devoured.

Numbers this year were down again. Interest in phone operations seemed to be down as the station was sometimes idle for lack of an operator, however, I think there were more CW operators than in the past. Though they were probably less experienced, they seemed to be doing a fine job. The satellite team did an outstanding job making 22 contacts on 4 different satellites: AO27, FO20, FO29, and RS15. And finally, the number of helpers during setup and teardown seemed better than last year and that's great!
