The Rettysnitch A bit of anatour radio history

The Rettysnitch is a close cousin to the Wouff-Hong. While at first glance they appear to be two tools for the same job, there is a fine line between their purposes. The Wouff-Hong is used to enforce law and order, whereas The Rettysnitch is used to enforce decency.

Both The Wouff-Hong and The Rettys-nitch were originated (or at least popularized) by none other than the founder of the American Radio Relay League, Hiram WIAW Percy Maxim, also known as "The Old Man" or simply "T.O.M." Both instruments were first described in 1917.

In 1921, the Washington DC Radio Club presented The Rettysnith to the league's traffic manager. According to legend, the club received The Rettysnitch specimen from "The Old Man" himself. It was ordered to be displayed by its mate, The Wouff-Hong. These legendary instruments can be seen today at the ARRL museum in Newington, CT.

L. B. Cebik, W4RNL, wrote in the September 1996 QST, "In 1930 The ARRL Handbook had pictures of both instruments of enforcement. By 1936, only the Wouff-Hong appeared. By 1947 the Handbook had deleted both photos." Cebik said of The Rettysnitch, "Even at its first public appearance, two of its teeth were missing, suggesting a long history of necessary and effective use. However, to the day, The Rettysnitch has lost no further teeth."

HISTORY

Many of us can remember when P&H Electronics manufactured some top of the line amateur radio equipment right here in Lafayette, at one time on Columbia Street in downtown Lafayette. You can check with Jim Collison, K9LYA, among others, as some of the local hams that worked there.

If you can remember a little further back (we barely remember seeing some of their ads in some ham magazines, prior to 1955) the following article that appeared in the <u>Lafayette Journal/Courier</u> on 23APR99 might bring back memories. For the rest if us, it will be educational.

Great people of Greater Lafayette Walter E. Doolittle

W. E. Doolittle was born and raised in Lafayette. He was educated at Purdue University and worked for many years at the Western Union Telegraph Co. and various telephone companies. His early experiences made him well adapted for his late business ventures.

Doolittle founded the Sterling Electric Co. in Chicago in 1898. The company grew quickly, and to avoid labor problems and to increase capacity, Doolittle reorganized and enlarged the firm and moved it to Lafayette late in 1899. At the time of its move to Lafayette, the company, which made telephones and switchboards, employed 75 people.

Considered one of the best institutions in Lafayette at the time, Sterling Electric went from 30,000 square feet of space to about 125,000 square feet, and eventually employed 500 at its three-story building on Second and Mechanics streets. Doolittle served as president and treasurer, and officers included Thomas Duncan, Brown Brockenbrough and R. B. Wallace. Sterling Electric was recognized around the nation as a leader in its field.

ARRL NAME CHANGE COULD BE

ON PAPER ONLY

She & I are not the only one to have expressed our dis-pleasure with the HamVention folks on this. A good friend is one who remembers your birthday, but forgets the Swallowing angry words is a lot easier that having to eat them.

In lieu of a legal name change. the ARRL Executive Committee will recommend to the Board of Directors to emphasize the abbreviation "ARRL" in conjunction with the tag line "The National Association for Amateur Radio." The action came at the Committee's meeting May 1 in Irving, Texas. The move, if accepted by the full Board, would not actually change the name of the organization, but the "ARRL" moniker and tag line would appear on all League correspondence and publications instead of the full name.

In other Committee actions, the EC voted to reaffirm the League's position that the FCC continue to issue a paper license document to amateur licensees. The Committee also was advised that the League will not seek FCC reconsideration of its petition to expand the special events call sign program. The FCC turned down the request last month but invited the League to revisit the issue later.
