# TARA minutes April 9, 2002

President Jim Darling called the meeting to order at 7:30 pm.

Secretary Jim Haynes read the minutes from last month's meeting. Tim Gardner motioned to accept the minutes as read seconded by Dave Dull. The motion passed.

### Treasurer's Report

Dave Dull reports this month: Total Income: \$50.84; Disbursements: \$6.80; Beginning Assets: \$9166.37; Ending Assets; \$9210.41.

We received a bill for equipment insurance this month. Dave reports 178 unique hits on our club website and 1491 total hits.

#### **Old Business**

The Morse Code classes being taught by Steve VanFrank have begun. Classes are Sunday and Thursday evenings at 8:00 pm. So far Steve has two students. Anyone is welcome. Feel free to join the class whether to learn for the first time or like me, to refresh your memory for code.

Steve VanFrank finally found the correct battery holder for the club's MFJ antenna analyzer. It's an unusual holder for both AA and 9v batteries. Thanks to Steve for being alert to the find and the repair of the analyzer.

#### **New Business**

This month's program meeting will feature our very own KB9SSS Dana Hoggatt. Dana, or Muck as his friends refer to him, will demonstrate computer antenna modeling. He is going to model our Field Day antennas and show how various configurations affect radiation patterns.

Vice President Curtis Sherwin announced that several members who were usually present at Field Day have other commitment this year. Therefore, we will need other members who maybe haven't been active at Field Day to fill in the needed manpower this year. One particular position of importance is Chief Cook. Remember, even if your license doesn't allow HF privileges you can operate HF with a properly licensed control operator at the station. This year instead of a Novice station there is a GOTA (Get On The Air) station allowed. This station allows nearly any one with or without a license to operate, again with licensed control operator present. This is a chance to introduce non-hams to the hobby. Curtis says we could operate up to three HF stations this year. Again, manpower will be needed. Let Curt know if you are available to help.

President Jim received an interesting e-mail from N9YNF, David Pifer the Vigo County ARES Emergency Coordinator. The World Hover Craft Championships are coming to Terra Haute September 14-25. They are asking the Wabash Valley Amateur Radio Association (wwwlw9uuu.org) for communication support. On September 14 there will be a cruise up the Wabash River to Lafayette where they will camp overnight and return the next day. David is proposing out two clubs get together to monitor the progress of the cruise at various places along the river. Obviously there will be some details to work out so if we are interested the sooner we can talk to David the better. If you are interested in helping out this event speak up. This could be a valuable exercise for our club in communicating with another organization. If nothing else, it's a good excuse to go out and play.

President Jim brought up two issues he feels need some action. The first, raising club dues. The second, selling older, unused equipment. Some subjects can reduce a meeting to a level of confusion similar to that of the location of an Arab terrorist. I will attempt to accurately and coherently represent the next 45 minutes of the meeting.

The price of membership does not cover the cost of publishing and delivering the Tattler. With every new member we lose more money. Costs will continue to rise. Postage is rising nearly every other year. One idea mentioned was if we have nine thousand dollars in the bank why raise dues? The money the club has now came from years where the Hamfest made a lot more money than it does for us now. The treasury is a limited source and cannot support publication forever. Several suggestions were offered generally suggesting electronic publication with e-mail distribution and /or publication on the website. One issue with raising the dues is that the amount is written into the club bylaws. A change would require a majority vote of the whole membership. When the average attendance at a business meeting is less than fifteen the decision would require a proxy vote. With this one subject, club dues, we have two issues to consider. One is the cost of club operation. The other, making adjustments in the by-laws to ease the process of keeping pace with the rest of the world.

Mark McGregor, KB9KHM, suggested the treasurer submit a report to determine the budget needed to support the basic club operations. Since that was the one idea everyone could agree on President Jim decided we would table this discussion until next month.

I've decided to present the next discussion in a more personal manner than the last. I felt the opinions expressed were important to the future of this club and that anonymity would diminish that importance. That's just my opinion. You're stuck with it for now.

President Jim presented the subject of selling older unused equipment, specifically the Ten-Tech Corsair and the Yeasu 726. The proceeds could then be used to buy another Icom 746. This would give the club two similar radios. The advantage is having less equipment to be familiar with in an emergency situation. He then asks, "What is this club for?" One purpose obviously is emergency communication. That is our obligation to the Red Cross. Another reason for the club to exist is to give the members a place to operate. If someone doesn't have their own equipment available or if there is an on-air club event the shack is available. Jim would like to hear other opinions.

Vice president Curtis offered the following: The old radios aren't losing value where they are. A new radio loses value as soon as you open the box. New features such as DSP, are evolving quickly. The next generation of features is due to be released in less than two years and we should wait. When Curtis asked if there was any equipment we needed to fulfill our Red Cross obligations? The consensus was a rather resigned "no".

Muck, KB9SSS, (see above) told us that the club had exposed him to a variety of activities that he would never have experienced on his own. He also observed that newer hams seemed to like newer equipment with more features while the older hams preferred the older equipment with simpler more basic features.

Mark, KB9KHM has his own satellite equipment and would like to see an ATV repeater in the area. It could support emergency communication and is receivable by anyone with a television set at zero additional investment.

Steve VanFrank feels that any club ought to be what the active club members want it to be. This club is a static group where 90% of the members don't participate. That means the active 10% should define what the club should be. We have the resources to make it anything we want. Most clubs don't. There will always be a newer, better model in the future. In the mean time we have equipment sitting unused.

With the discussion nearing exhaustion Muck made a motion to sell the 726, just the 726 and just to sell it. He also stipulates that the vote be taken next month. Mike Kantz, KB9VZD seconded. The motion is tabled until May.

# Moving right along:

Since the club now has a nice computer Muck made a motion to buy two BUX Comm interfaces, one for the ICOM 746, and the other for the Yaesu 847. These will allow us to do PSK 31. Jim Haynes seconded the motion. The motion was passed.

Muck, at this time the only one left with a voice, wanted to let us know he participated in the CQWPX contest last weekend from the club station. He managed 199 contacts in his solo effort. He also noted that the club has no logging software. He suggested appointing a committee to make a recommendation.

Tim Gardner again wants to remind everyone of the Indiana State QSO Part on Saturday May 4<sup>th</sup>. Tim is the chairman of the organization committee. He would appreciate our on air support. See the website at <a href="https://www.hdwcc.org">www.hdwcc.org</a> for full information.

In 2002 Hamvention will be celebrating its 50th anniversary and its 51st show. The theme of this year's show is Emergency Communication and Preparedness.

International attendee interest is very high for this year's show. We are hopeful that the State Department is prompt in approving travel visas so our international amateur radio friends may attend.

We will be using the Salem Mall parking lot this year for all park-n-ride parking. The space allocated to Hamvention has been increased so we will not need Buses will run Forest Park. between Hamvention and Salem Mall, as in past years. The bus fee will be the same as last year, \$2.00 per day, per person. year we are offering an advanced sale combo ticket. It is the admission price of \$17.00 plus a \$3.00 bus fee, good all weekend. Showing this advanced sale ticket will allow the user to ride the park-n-ride buses for a one-time fee. Advanced sale tickets are available until May 16.

Alternate activities for the none-ham include on-site bingo and transportation to several local activities, a quilt show, the Air Force Museum or the Dayton Art Institute.
