

The meeting was called to order by at 19:33 by WB9SWD.

### Officer Elections

WB9BRX and WB9SWD have each agreed to run for new terms in their current offices (Treasurer and Vice-President, respectively). Nominations were accepted from the floor. N9GKE was nominated for President and N9LF was nominated for Secretary. There were no additional nominations. As no office was contested, the slate was accepted by acclimation. Later in the meeting, it was pointed out that we needed to elect a Director, as the previous president has resigned. W9TN was the only nomination and by general acclimation was elected Director.

# **Old Business**

N9GKE reported that the antenna tower has been inspected and determined to be a sound structure but noted that it needs to be painted. The inspector also re-installed our rotor for the tri-bander. TARA cost for this service is \$332.50. As per the agreement, the Red Cross will pay the \$190 inspection fee, plus \$56.70 travel expenses.

The Red Cross is pursuing a "hold harmless" agreement that would once again permit TARA members to climb the tower. It was assumed that TARA was incorporated, but there was discussion that while we once were, no paperwork to that effect has been executed in recent years (meaning our registration with the state has expired). N9NWO will pursue this with the Secretary of State to resolve the matter.

WB9SWD noted that after the rotor was reinstalled, the control box is malfunctioning. W9YE offered to supply a known good control box for testing purposes.

N9GKE stated that we have been operating at a deficit, and that we need to raise the annual dues to make up the difference. Considerable discussion ensued. It was agreed that we should pursue changing the By-Laws (which currently specify the amount of the dues) to simplify the process for future changes. When this was last actively discussed, we proposed publishing in the Tattler the purpose and proposed textual changes. W9TN agreed to write the article. It was further agreed that the proposal would appear in two successive issues of the Tattler, and that a self-addressed, stamped post card would be included in the second issue, to permit voting by mail. W9YA agreed to collect the mail-in votes.

The 2003 Banquet dinner will be held at the Golden Corral (SR 26E, just east of Target) on Wednesday, January 22 at 7pm. We have a semi-private room reserved for our use.

# **New Business**

N9GKE asked for volunteers to audit the books. W9YA and W9TN agreed and will meet with W89BRX to arrange a time/date/place.

The minutes from the December meeting have not yet been published in the Tattler, so will be read at the February meeting.

WB9BRX gave the Treasurers report. We had income of \$363.47 and no expenses and a bottom line total of \$8811.16.

N9GKE moved to close the meeting and N9YTE seconded Motion passed. Meeting adjourned at 20:05.

Kenneth Newcomb, KA9WYA, petitioned for membership (via postal mail). Since he has included the requisite monetary funds, he was accepted for full membership.

N9GKE called for a motion to pay the \$332.50 charge for the rotor installation. Motion passed.
