Transportation to Dayton




Field Day - Are You Ready?

Field Day - Class F ???

At recent TARA meetings, there has been some interest and discussion about operating Field Day this year as a Class F station. Just what *is* a Class F station, you ask? Here's the official ARRL entry category definition:

(Class F) Emergency Operations Centers (EOC): An amateur radio station at an established EOC activated by a club or non-club group. Class F operation must take place at an established EOC site. Stations may utilize equipment and antennas temporarily or permanently installed at the EOC for the event. Entries will be reported according to number of transmitters in simultaneous operation.

In short, it would allow us to operate from the club station at the Red Cross. This means air-conditioning, clean restroom facilities, an available kitchen, and all the amenities the facility has to offer. All of the equipment and antennas currently inplace could be used, providing all the Field Day rules for Class F are followed.

Of course, many Hams love the traditional outdoor, in-the-heat-and-mosquitoes, type of portable operation. It represents the spirit and challenge of what we have all experienced as being the true flavor of Field Day. But is it time to change our thinking? Or maybe at least consider the addition of a new type of "emergency" communications exercise?

With all that has happened since 9-11-2001, Emergency Operations Centers are becoming a focal point for government agencies and volunteer organizations. Amateur Radio has always played a part in providing disaster communications, and our role in supporting operations at local EOC's is vital.

The Class F category for Field Day merely provides groups the *option* of operating from established EOC's. If that's something we feel is timely and warranted for our club, then maybe we should consider that an option this year. Consider, too, that some club members who are reluctant, or even unable, to venture out into the heat and wilderness of our usual Field Day site, may be inclined to pay a visit, or even participate in operating, if it were held at the Red Cross.

There will be base stations, mobiles, portables, and maybe even an aeronautical mobile station, working as many Indiana stations as possible.

Operation will take place on 160, 80, 40, 20, 15 and 10 meters in both CW and voice. Every Indiana County is a multiplier. Try to work all 92! The fun element is added by the fact that you may rework the same mobile or portable station in both modes, on every band, every time that station moves to a different county! There will be many mobiles traversing the state, and portable stations activating new counties as they move. The contest runs from 10am-10pm EST, and is sponsored by the Hoosier DX and Contest Club (HDXCC).
