

From the K9FOH QSL file



Welcome again from K9FOH. Here are some more vintage QSL cards. All of these were involved in the Vietnam War in Southeast Asia. The DU5DM (photos, page 2) was a special event commemorating Douglas MacArthur's return to the Philippines. I managed to work that event a couple of different times, but don't know if they are still happening.



The HS4AGN was from one of the air bases in Thailand. There were quite a few military members in Vietnam from Australia, New Zealand, and Korea with VK3AKR, ZL1AMN, and HL9TT represented those countries. Taiwan (Formosa) was rather hard to work during the 1960s & 1970s (perhaps longer), but in the early 1960s there were several MARS stations that had Amateur calls and BV1USG is from the Air Force MARS station in Taipei. I don't remember all the details, but the US Forces stations had to stop operating on the ham bands because of some incident involving a US ham in the early 1970s, I think.


